## National Survey of CSHCN

- Administered by Centers for Disease Control and Prevention and National Center for Health Statistics<sup>2</sup>
- Phone survey conducted between 10/2000-4/2002
- Nationally representative and state representative samples
- 744 CSHCN in MA; 4,476 in NE; 38,886 in US


### **Health Care Services**

- Routine care
- Specialty care
- Dental care
- Prescription medication
- Special therapy
- Mental health services
- Substance abuse treatment (age 8+)
- Vision/hearing care and devices
- Home health care
- Medical supplies and equipment
- Mobility aids (age 3+)
- Communication aids (age 3+)

### Family Support Services


- Professional care coordination
- Mental health care/ counseling for family member(s)
- Respite care
- Genetic counseling

### Need for Health Care Services, MA



Hearing care/devices, Mobility aids, Home health care, Substance abuse treatment and Communication aids all less than 10%

### Frequency of Needs - MA Summary


- 98% of CSHCN in MA needed at least 1 health care or family support service in the past year.
  - 98% needed at least 1 health care service
  - 29% needed at least 1 family support service

### Unmet Need, MA

- 1 in 6 CSHCN in MA (or an estimated 35,140) who reported a need for services in the past year did not receive the needed care.
  - 13% had an unmet need for health care services
  - 21% had an unmet need for family support services
  - 6% had more than one need unmet


### Unmet Need, MA


## Unmet Need and Child/Family Characteristics, MA

- With each increase in age, CSHCN were 1.07 times more likely to have an unmet need (OR=1.07).
- CSHCN who were uninsured anytime in past year were nearly 5 times more likely to have an unmet need than CSHCN privately insured (OR=4.95).
- There was no significant difference in unmet need for children of different gender, race, and Hispanic ethnicity.

# Unmet Need and Child/Family Characteristics, MA (cont.)

- CSHCN who are usually or always affected by their condition were 3 times more likely to have an unmet need than children who are never affected by their condition (OR=3.15).
- CSHCN who have health care needs that constantly change were 3x more likely to have an unmet need than CSHCN whose needs are stable (OR=3.26).


### Unmet Need and Insurance, MA

### MCHB National Agenda

"Provide and promote family-centered, community-based, coordinated care for children with special health care needs and to facilitate the development of community-based systems of services for such children and their families."

## Service Systems Results, MA

MA families and progress towards communitybased systems of services:


Family does not feel like a partner in decision-making	36%
Child does not receive care within a medical home	39%
Child does not have adequate health insurance	35%
Community-based services not organized	21%

## Unmet Need and Service Systems, MA

- Protection from having an unmet need is related to:
  - CSHCN receiving coordinated care within a medical home were less than half as likely to have an unmet need than CSHCN who did not receive care in a medical home (OR=0.46).

## Unmet Need and Service Systems, MA

### All CSHCN, MA - Summary

- The most vulnerable of CSHCN (uninsured, more severely affected by condition) were more likely to report an unmet need.
- Receiving coordinated care in a medical home seems to be a protective factor against unmet need.
- However, 2 in 5 CSHCN in MA do not receive care in a medical home.

# Analysis of CSHCN with More Severe Conditions

## Severity Sub-sample

- Unmet need related to severity of the child's condition.
- Therefore, a sub-sample of CSHCN with more severe conditions was selected to compare types of need and rates of unmet need among this population.
- Includes 94 (13%) CSHCN in MA selected if:
  - Positive for 2 or more CSHCN Screener items AND either:
    - Condition affects ability 'a great deal'
    - Parent Rank of severity 8+ (on scale of 0-10)

## Sample Demographics, MA

6-12	48%	42%
13-17	35%	37%
Female	38%	31%
Non-White	16%	19%
Hispanic	9%	10%
Below 100% FPL	17%	24%
Ever uninsured in past year	7%	4%

Differences were not determined to be statistically significant at p <.05



### Need for Services, MA




All differences on chart were statistically significant at p <.05 Needs for all other services were not significantly different between all CSHCN and CSHCN with more severe conditions.

# Severity Sub-sample, MA - Summary

- •CSHCN with a more severe condition need more services (such as specialty care, mental health care, care coordination and respite care) than all CSHCN.
- More than 1 in 3 CSHCN in MA with a more severe condition who reported a need for services in the past year did not receive the needed care.

### **Policy Implications**

- Policy options include
  - Improve health insurance systems for families including employer-based insurance.
  - Improve employee benefits (e.g. paid time-off for doctor visits).
  - Improve service systems, in particular, ensure coordinated care in medical homes.
  - Develop targeted services for CSHCN with severe conditions.
